**“Where the Fight is, is Where you Fight”**  
***THE ERIC STEIN SHOOTING***

This presentation will take an in-depth look from start to finish of the tragic shooting that occurred in Keokuk County, Iowa on April 4, 2011. On that date, Keokuk County Sheriff Jeff Shipley, Chief Deputy Casey Hinnah and Sergeant Eric Stein attempted to make contact with Jeffrey Krier at Krier’s residence located in rural Sigourney, Iowa as part of a follow-up investigation. Krier was suspected of making threatening telephone calls, firing weapons in occupied structures, and breaking into a residence in search of his make-believe wife who he felt had been kidnapped and was being taken to Texas.

Keokuk County Sgt. Stein was shot and killed during this altercation.

### **ARLEN CIECHANOWSKI**

Director, Iowa Law Enforcement Academy

Governor Branstad appointed Arlen Ciechanowski to the position of Director for the Iowa Law Enforcement Academy (ILEA) on April 4, 2011. Arlen is the fifth person to serve as the Director of the Academy since its creation in 1967.

He had been the Assistant Director of ILEA from June, 1996 through April, 2010. Arlen has been employed in the law enforcement field since 1974. The positions included in this tenure include: Deputy Sheriff for Story County Sheriff's Office and Patrol Officer for the Ames Police Dept. In 1982 he became an instructor at ILEA, teaching in most areas of the curriculum with specialization as the primary firearms instructor.

*Iowa Division of Criminal Investigation (DCI)*

- Began his career with DCI in 1995
- Assigned to the DCI's Gaming Unit from 1995-1999
- In 1999 transferred to the Iowa Division of Narcotics Enforcement
  - In 2006 transferred back to DCI's Major Crime Unit
- Is responsible for investigating and testifying in a variety of felony cases in include homicide, embezzlement, public corruption, officer involved shootings, sexual assault, bank robbery, kidnapping, and missing persons
