CHEROKEE COUNTY SHERIFF'S OFFICE

Jerod served his country as a Marine specializing in security forces during war and peacetime. He was hired by the Iowa State patrol, was assigned to the SWAT team, Clandestine Lab Emergency Response Team and Meth Lab Clean-up Team. He was then asked to start Iowa's Criminal Interdiction Unit and was a K-9 handler and team leader. Working on this team, he received the nation's highest award for Drug Interdiction Team of the Year. He then

worked undercover operations in organized crime and vehicle theft in western Iowa. He was also a recipient of the State of Iowa's "Mothers Against Drunk Driving Award" for OWI enforcement.

In 2016 Jerod retired from the Iowa State Patrol after 20 years of service. He was elected Sheriff of Cherokee County in 2016 where he is currently working hard serving the citizens of Cherokee County. He has a passion for fighting crime and connecting with his community. Jerod is currently working to start the reserve program for Cherokee County.

### **KRIS COVI**


