## **PERIOD 1 - HOSTAGE/BARRICADED SUBJECT INCIDENT RESOLUTION**

The Marshalltown multi-jurisdictional Crisis Negotiation and SWAT Units will provide training on the response to Barricaded/Hostage Incidents. The Crisis Negotiation Team will discuss techniques for engagement. De-escalation, team roles and responsibilities, managing intelligence, equipment use, and set-up, as well as strategies to overcome verbal and emotional resistance from those involved. SWAT members will discuss planning, containment and observation strategies, team roles, and equipment available for rapid deployment and emergency entry tactics.

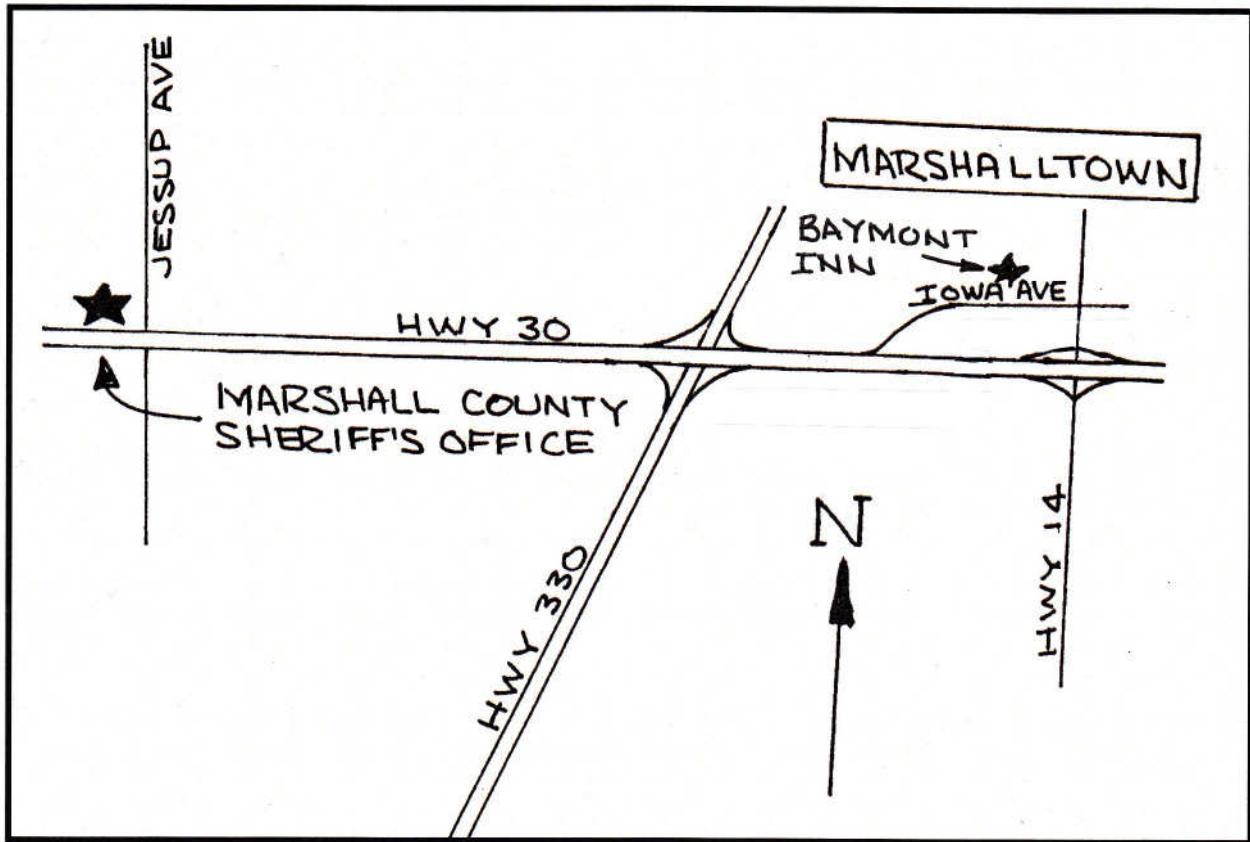
