The morning 4-hour session was presented by Lt. Tricia Thein of the Marshalltown Multi-Jurisdictional Crisis Negotiation Team and members of the Marshalltown Multi-Jurisdictional Swat team explained their role in the types of situations.

The afternoon 4-hour session was presented by Marshall County Jail Administrator Pat White. He explained how the state's 9th largest jail works. Tours of the facility followed and were conducted by members of the MCSO jail team.
